- Receipt of deferred stock under the Plan and the Terms and Conditions in lieu of 50% of the Retainer (as defined in the Terms and Conditions) and dividends.
- Represents 688.9029 shares of deferred stock in lieu of 50% of the Retainer plus 9.7588 shares of deferred stock in lieu of dividends.
- Represents the Average Trading Price (as defined in the Terms and Conditions).
